Lift tickets for Sly Fox Western Ski Trips.

This year, Sly Fox is doing 2 trips at Epic Pass resorts, Park City and Crested Butte. You must buy your lift tickets separately for these trips, and the sooner you buy them, the better the price. You have two options:

1. Epic Day Passes. These are daily tickets costing about \$100 per day (depending on what resort and how soon you buy). These are subject to blackout dates, Since our Park City Trip is over Presidents Day weekend, the first Sunday after we arrive is a blackout date and will cost substantially more to ski on that day.
2. Full Season Epic Pass. This is a season pass for all Epic Pass resorts, and costs about \$1100. The cost of the pass increases over time and must be purchased before Thanksgiving. It is not subject to blackout dates, so can be used on the first Sunday of the Park City trip.

You should buy these passes from Skigroup.net as soon as you sign up. When you buy from Skigroup.net, you will receive a \$50 trip rebate for the Park City trip on 5 or more Epic Day Passes or the Full Season Epic Pass. Please note that these are nonrefundable, so not part of the individual Sly Fox Cancellation policies.
